LAST BUT NOT LEAST.... GRANT UPDATE

As you are aware, every year we write a grant to secure Hazardous Abatement Board funds for OSHA training in dealerships. This is provided free of charge to our members and has become more important with OSHA changes and insurance company requirements. This year, we have utilized every training session approved, with the grant year ending on July 31st. We have written another grant and hopefully will get approval by May and can start scheduling the new sessions August 1st

We do request that you provide suggested subjects so we can incorporate them in the following grant year proposal. Our research for subjects is based on dealership input, changes in OSHA standards and regulations, and issues that have occurred in dealerships that create claims. As an example, the local OSHA office asked us previously to include lift safety in our subjects and we accommodated their request.

You can check with Pam if you have not scheduled a session to see if there are any cancellations. This is another strong example of the S.A.D.A. working for you.
