



Cameras on Auto Row

While our M.O. has always been to represent our members in a positive and quiet manner, we have recently accomplished something that is very significant and we wanted to let everyone know. Yes, we quietly handle issues for our dealers related to legislative matters, regulatory issues, employee relations, auto show, charity preview, etc... but this week we witnessed the start of something very important to our West Genesee Street (Auto Row) dealers.

Over the years there have been a significant number of thefts and vandalism that has plagued the Auto Row dealers. The surrounding neighborhoods are not good and our members often had of thefts. At one point, after working with the Syracuse Police the dealers hired an extra patrol for certain evenings — the cost of this additional officer was

absorbed by the Auto Row dealers. We have always been involved with the meetings and providing the police department with all information pertaining to thefts and vandalism to assist them building a case.

A little over two years ago we suggested to the dealers that they should request police survelliance cameras – these were currently being installed in higher crime areas. We drafted the letter to Mayor Minor who immediately had Police Chief Frank Fowler have a meeting with our dealers in the SADA office. He explained that the process was through the NYS Legislature and that he would do what he could to assist. They then met with Assemblyman William Magnarelli in his office and were joined by Police

Captain Steve Lynch, who is in charge of the Auto Row district. Assemblyman Magnarelli sponsored the legislation that was passed, followed by an almost two year process for funding and approval.

If you drive down Auto Row today you will see the cameras installed in the 600 block of West Genesee all the way down to Geddes. We have drafted correspondance to the Mayor, the Police Chief and Assemblyman Magnarelli thanking them for their efforts.

Our office represents everyone and will do whatever we can to assist you with your issues of importanc. While this was a tedious process, the end results of the installation of the police survelliance cameras illustrates our commitment and dedication to all of you.
